

Registration Agreement:

When completing this online registration form, please complete the entire registration process and **confirm receipt of an enrollment email**. If you do not receive an enrollment email please contact info@lindabulgosmusicalproductions.com to confirm your registration.

Please ensure you **register with a valid email address** and add "info@lindabulgosmusicalproductions.com" to your contacts list. Frequent class communications and important information will be sent home via email only.

Please carefully **review the full class description** prior to enrolling your student. You are responsible for knowing and committing to all class, rehearsal, and performance dates/times for your class. Please refrain from scheduling dentist appointments, tutoring sessions, etc. during class times. Putting on a show is a group effort, and missing rehearsal causes difficulty for every other student involved. If you have an unavoidable conflict, please inform Linda as soon as possible so that the rehearsal schedule can be planned around your child's absence.

Students need to **bring black jazz shoes to every class**. Some students in the Fall/Spring Productions may also be asked to provide black character shoes (this will depend on casting).

Musical Theater is a class with performances at the end. Classes and rehearsals should be taken seriously and every class/rehearsal is important. **Please do not schedule appointments during our class and rehearsal times.**

Please fill out all registration information completely. Returning families, please take a moment to update your child's age, grade, and T-shirt size.

At the end of the registration process, you will have the option to pay in full, or pay a non-refundable deposit of \$100 per student, which will reserve your child's spot. **This deposit is non-refundable.** Any remaining balance is due by the first day of class and can be paid online or by personal check. No refunds will be issued after first class. No refunds will be issued for any missed classes or camp days.

In the event that a class is full, please register but do not pay the deposit. You will be placed on the waitlist. No deposit is required for waitlist registrations until after a spot becomes available for you.

<u>Deposit</u>	I understand that the \$100 deposit is nonrefundable. This deposit is required in order to reserve a student's place in the class or camp. The remaining balance is due on or before the first day of class.
<u>Waiver</u>	<p>WAIVER:</p> <p>In consideration of being permitted to participate in any way in Linda Bulgo's Musical Production's (LBMP) programs in which I have enrolled my child (participant) I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue LBMP, its directors, officers, employees, agents and all other persons acting on its behalf, from liability from any and all claims including negligence of LBMP, its directors, officers, employees, agents and other persons acting on its behalf, resulting in personal injury, accidents or illnesses, and property loss arising from, but not limited to, participation in LBMP, whether at its premises or elsewhere. <u>Release</u>	My child has permission to participate in the activities of Linda Bulgo's Musical Production's (LBMP). I understand that I will be responsible for the cost of any emergency medical and dental care that may be necessary for my child while in class, and hereby give my consent to Linda Bulgo's Musical Productions (LBMP) to obtain all such emergency medical and dental care. This care may be given under whatever conditions are necessary to preserve life, limb, or for the well-being of my dependent.
<u>Media Permission</u>	LBMP takes photographs and video and/or audio recordings of rehearsals, productions, and other LBMP activities. These are used in support of LBMP and its mission. Their uses include, but are not limited to, brochures, the LBMP Web site, and PR including press kits sent to the media. LBMP appreciates your cooperation in consenting to give LBMP permission to use student's image to appear in LBMP publications and promotional materials as described herein. I understand the images and/or recordings will be used primarily to promote the activities and image of LBMP; the images and/or recordings will be the sole property of LBMP, and there will be no wages or payment of any kind in return for these appearances.
<u>Volunteer Requirement</u>	I agree to sign up for 5 hours of volunteer work or pay a buyout of \$100. Volunteer sign-up (or buyout purchase) must be completed at least one month prior to each production. More information about volunteer opportunities will be provided within the first few weeks of class. No volunteer hours are required during summer camps, only during Fall/Spring Productions.
<u>Family Agreement</u>	I understand and agree that students are not to enter or exit the classroom and premises without either 1) being accompanied by a LBMP instructor; or 2) without being signed in (upon entering) and out (upon exiting) by an individual authorized herein, or hereafter, by a parent/guardian of the participant named above.
<u>Ticket Sales Requirement</u>	I understand that I am required to sell or purchase 10 tickets to this session's production. I understand that if I have two or more children enrolled in this session, I am required to sell or purchase 15 tickets to this session's production. These tickets can be for any of the three shows that your child is in or for any of the other six shows being put on by the other casts. More details on the ticket sales process will come via email. No ticket sales are required during summer camps (performances are free), only during Fall/Spring Productions
